

**ANNUAL PASSHOLDER RED CARPET SWEEPSTAKES  
OFFICIAL RULES**

**NO PURCHASE OR PAYMENT NECESSARY TO ENTER OR WIN,  
NOR WILL A PURCHASE IMPROVE ONE'S CHANCES OF WINNING**

**1. SPONSOR:** Walt Disney Parks and Resorts, L.L.C., 700 West Ball Rd., Anaheim, CA 92802, whose decisions are final and binding as to all aspects of this Sweepstakes.

**2. ENTRY:** This Sweepstakes is intended for all *Disneyland*® Resort Annual Passholders 18 or older who are in possession of a valid *Disneyland*® Resort Annual Passport as of February 18, 2006 ("Members") and who correctly answer the trivia question regarding the 2006 Academy Awards® presentation ("Question"). During the period commencing at 12:01 A.M., March 5, and ending at 7:00 P.M., April 5, 2006, Members may enter this Sweepstakes by visiting [www.disneyland.com/ap](http://www.disneyland.com/ap) ("Website") and following the instructions there for downloading an entry form. The entry form must then be completed, including Annual Passport Number and correct answer to the Question, and mailed inside a postage prepaid business size (#10) envelope, to: Annual Passholder Red Carpet Sweepstakes, P.O. Box 610954, Anaheim, CA 92803-6194 ("Entry"). For purposes of these Official Rules ("Rules"), all times are Pacific Time.

**3. LIMITATIONS:** All Entries must be received by 7:00 P.M., April 5, 2006. Only one Entry per Member. Entries by any method other than set forth above in Section 2 are void. Open only to Members who are not employees of Sponsor, American Broadcasting Corporation, Inc. ("ABC"), or the Academy of Motion Picture Arts and Sciences ("Academy"); or their respective parent, subsidiary or affiliated companies; the advertising, promotional or fulfillment agencies of any of them (individually and collectively, "Entities"); nor members of their households or immediate families. Neither the Entities, nor any of their officers, directors, shareholders, employees, agents or representatives (individually and collectively, "Releasees") are responsible for Entries from persons who are not Members, or Entries that are altered, delayed, deleted, destroyed, fraudulent, illegible, improperly accessed, inaccurate, incomplete, interrupted, late, lost, misrouted, multiple, mutilated, non-delivered, postage-due, stolen, tampered with, unauthorized or unintelligible; or any printing, production, technical, electronic or other errors; or for lost, interrupted or unavailable network, server or other connections; miscommunications; failed phone, computer hardware or software or telephone transmissions; technical failures; unauthorized human intervention; traffic congestion; garbled or jumbled transmissions; undeliverable e-mails resulting from any form of active or passive e-mail filtering; insufficient space in entrant's e-mail account to receive e-mail; or other errors of any kind, whether due to electronic, mechanical or human error or other causes; even if caused by the negligence of any of the Releasees. Each of such potential Entries will be disqualified. Void where prohibited or restricted by law and subject to all applicable federal, state, local and municipal laws and regulations.

**4. PRIZE: One (1) GRAND PRIZE:** One (1) set of two (2) Pre-event tickets for Red Carpet Bleacher Seats to view the Red Carpet arrival of those attending the 2007 Academy Awards® presentation ("Ceremony") at a date yet to be determined. ABC will telecast the Ceremony and provide the Red Carpet Bleacher Seats, but the prize does not include entrance into the Ceremony or the Kodak Theatre. All expenses not specifically mentioned herein are not included and are solely the winner's responsibility, including but not limited to transportation to and parking at the Pre-event. Prize is subject to certain restrictions and Sponsor's approval. Red Carpet bleacher Seats are non-transferable, have no retail or re-sale value and are not redeemable for cash. No substitution allowed except, at Sponsor's sole discretion, a prize of equal or greater value may be substituted. Winner may be required to present valid Annual Pass in order to qualify for prize.

**5. PROCEDURES:** Sweepstakes begins at 12:01 A.M., March 5, and ends at 7:00 P.M., April 5, 2006. Each Entry must be complete with a correct answer to the Question to be an eligible Entry. On or about April 15, 2006, in a random drawing, winner will be selected from all eligible Entries received. Odds of winning depend on the total number of eligible Entries received.

**6. WINNER:** Potential winner will be notified by U.S. Mail on or about April 30, 2006, and will be announced on the Website. Disqualification may result from any of the following: **[1]** potential winner's failure to respond to notification within ten (10) days from the date of transmission; **[2]** the return of any notice or the prize as undeliverable; **[3]** potential winner's failure to execute and return an Affidavit of Eligibility/Liability/Publicity Release within ten (10) days after its mailing; **[4]** potential winner's failure to claim the prize within ten (10) days after it is sent; **[5]** potential winner's failure to be available to attend the Pre-event and **[6]** any other non-compliance with Rules. In the event of a disqualification, no alternate winner will be chosen and the prize will not be awarded. Winner and guest must participate in the Pre-event together; and any minor must be accompanied to the Pre-event by his/her parent/legal guardian.
